# Terms and Conditions of Millwoods Community Church

## **Interments**

- No interment will take place unless the certificate of burial permit and purchase of a plot has been completed.
- Interments must be completed by Millwoods Community Church.

## **Columbarium Doors**

- Purchase and engraving of Niche doors are not included in pricing and are paid for by the family. The door engraving must be completed in 18 months of burial.
- \*All engraving is to be completed through Summit Memorials. The purchaser is required to contact Summit at their convenience.
- Millwoods Community Church Cemetery chosen font is required.
- Small porcelain pictures and/or very small flower vases that can be added to plot can be purchased at an extra cost (request at Summit Memorials)  
*\*The size of the Niche doors are 12" x 12" x 12" in size.*

## **Restrictions**

- Placing of flowers on the grounds are permitted in the flower containers near the plot or small flowers in a pre ordered flower vase attached to the tombstone. No other memorial items allowed on the grounds.

## **Cemetery Access**

- Access to the Cemetery will be from dusk to dawn throughout the year. You must be sure to close the gate when you leave the Cemetery grounds.
- If there is vandalism to the cemetery grounds, please contact the church office as soon as possible. The repairs will be the responsibility of the Millwoods Community Church Cemetery Staff.

## **Opening/Closings**

- A Millwoods Cemetery contractor will perform all openings and closings.
- All opening or closings will have a charge applied at time of purchase. Any additional openings/closings will require an additional charge.

## **Perpetual Care**

- There will be a charge for perpetual care on every sale; fee is charged again when placing a second urn in a niche.
- Funds are used for care, upkeep and renovations to the cemetery.
